Intended Use

- For the translucent replication of fine wood grains/ textures.
- · Recommended for indoor use.

Characteristics

- Dries rapidly.
- Wipe-resistant and waterproof.
- Good adhesion to paint and wood surfaces that are free from dust and grease.
- · Can be varnished with all König clear lacquers.
- Seamless lacquer application, ideal for precise touch-up work (fine strokes and dots).
- · Pen is non-refillable.
- Solvent-based product.

Application Notes

Remove cap – pen is immediately ready to use.

Depending on requirements, either dab on colour glaze with the pen tip lightly – without applying any pressure – or apply with fine, short lines.

If the glaze application is too heavy and hence too dark, it can be reduced or rather adjusted with Wire Wool or with the Sanding and Polishing Cloth when dried.

To prevent 'strongly soaking', untreated or raw wood (e.g. sanded through areas) from turning too dark, apply the colour glaze to a cloth and gently dab with the soaked area of the cloth.

When working on filled areas (e.g. with König fillers), apply a barrier coat to the substrate first using Special Repair Lacquer PLUS. For a final sealing, again spray over with Special Repair Lacquer PLUS.

To avoid contaminations, clean brush tip with a cloth or a rag from time to time. Prevent brush tip from coming into contact with lacquers, e.g. when retouching not completely dried lacquers. The tip may become sticky or rather resinous.

Close pen well after use – otherwise risk of drying up!
